Course Description

This class will explore current issues impacting law enforcement and homeland security professionals in the United States. The class will examine high-profile events impacting public safety and public reaction to these events. Specific areas of focus will include violent crime, use of force by law enforcement officers, homegrown violent extremism, cyber-attacks, international terrorism, transnational drug trafficking, and domestic intelligence and information sharing activities. Students will have the opportunity to interact with law enforcement professionals. Students are expected to stay up-to-date on current events.
